

Privacy Statement

This Privacy Statement applies to all personal information collected by MASI / AAMS 2019 through the internet, including without limitation, by way of MASI / AAMS 2019 website located at www.masisydney.org.au and www.aams2019.org.au.

MASI / AAMS 2019 recognize the importance of protecting the privacy of our clients and members personal and financial information and acts in accordance with this recognition. As a result, MASI / AAMS 2019 has instituted strict policies regarding your privacy. Information provided at the time of registration or purchasing will not be used for any unsolicited communication, unless you provide your consent. WHAT MASI / AAMS 2019 COLLECT

Will MASI / AAMS 2019 share your information with other entities?

- We believe it necessary to protect the rights, property or personal safety of another person or MASI / AAMS 2019;

If you do not provide requested information, MASI / AAMS 2019 may not be able to provide you with access.

SECURITY
